

Eligibility

Q) Are projects focused on any age-related neurodegenerative disease eligible for funding?

A) Yes. The Pasqual Maragall Researchers Programme will consider proposals focused on any age-related neurodegenerative disease, including:

- Alzheimer's disease
- Amyotrophic Lateral Sclerosis
- Argyrophilic grain disease
- Cerebral amyloid angiopathy
- Creutzfeldt-Jakob Disease
- Corticobasal degeneration
- Corticobasal syndrome
- Frontotemporal dementia
- Frontotemporal lobar degeneration
- Huntington disease, Huntington chorea
- Lewy body dementia

- Logopenic aphasia
- Motor neuron disease
- Multiple system atrophy
- Non-fluent progressive aphasia
- Parkinson's disease
- Pick's disease
- Primary progressive aphasia
- Prion diseases
- Posterior cortical atrophy
- Progressive supranuclear palsy

If your proposal will focus on an age-related neurodegenerative disease not listed above, please contact the PMRP Team (researchgrants@fpmaragall.org) before applying.

Q) I saw that this year there is a specific call for projects focusing on multiple system atrophy (Carles Colomer Prize for Multiple System Atrophy Research). Can projects focusing on multiple system atrophy still be submitted to the PMRP 2025 Call?

A) Yes. Applications focusing on MSA are still eligible to be submitted to the PMRP 2025 Call. In this case, they would be evaluated and ranked together with projects focusing on Alzheimer's disease and other age-related neurodegenerative diseases.

The Carles Colomer Prize for Multiple System Atrophy Research 2025 Call is a call within the Pasqual Maragall Researchers Programme specifically for projects on multiple system atrophy. Applications submitted to this call are evaluated and ranked separately from those submitted to the PMRP 2025 Call.



Q) What is considered to be basic research?

A) For the purposes of the PMRP 2025 Call, please refer to the following definition from <u>Eurostat</u>, the statistical office of the European Union:

"Basic research is experimental or theoretical work undertaken primarily to acquire new knowledge of the underlying foundations of phenomena and observable facts, without any particular application or use in view."

Please note that, as mentioned in the Rules for Participation, although the Pasqual Maragall Foundation considers basic research to be fundamental in the quest to beat age-related neurodegenerative diseases, basic research is not eligible for funding in the PMRP 2025 Call.

Q) What do you mean by translational research? Would in vitro or in vivo evaluation of new drugs or drug formulation be eligible?

A) By translational research we mean research undertaken with a particular application or use in view. As the *in vitro* or *in vivo* evaluation of new drugs or drug formulation would have a use in view, this would be considered eligible, providing of course that the drugs would be used to treat Alzheimer's disease or any other age-related neurodegenerative disease, <u>and the results of the project are not subject to any type of rights held by for-profit institutions at the time of <u>submission</u>.</u>

Q) In Collaborative Research Projects, do Consortium Principal Investigators (cPIs) also need to conduct translational or clinical research on Alzheimer's disease or any other age-related neurodegenerative diseases?

A) No. Principal Investigators (PIs) and Consortium Coordinators (CCs) must conduct translational or clinical research on Alzheimer's disease or any other age-related neurodegenerative diseases, but this is not an eligibility requirement for cPIs. We appreciate that, depending on the nature of the research project, consortiums might require another area of expertise and that cPIs may offer cross-cutting knowledge.

Q) What is considered to be a public or non-profit research organisation?

A) Any public or non-profit organisation that carries out research as part of its normal activity. Research does not need to be its primary activity. Examples: foundations, hospitals, research centres, universities. Please contact the PMRP Team (researchgrants@fpmaragall.org) if you have any doubts regarding the eligibility of your organisation.

Q) I am employed by a hospital and a foundation manages all of its research activities. Is it possible for the foundation to be named as my Host Institution/Partner Institution?

A). Yes. Please select the Host/Partner Institution according to how your organisation usually manages its grants.



Q) Does a Principal Investigator, Consortium Coordinator or Consortium Principal Investigator need to have a permanent contract?

A) No but they will need to have a contract for the duration of the proposed research project. If their current contract is due to end during the duration of the proposed research project, they need to confirm with their organisation that they will be supported for the full project duration should the project be selected for funding.

Q) Who do you consider to be an independent researcher?

A) To demonstrate independence a researcher should have at least one high impact publication as main author or without the participation of their PhD supervisor. Fulfilment of the eligibility criterion "to be principal investigator on at least one active, competitive research grant" also suggests that their institution allows them to manage projects independently and therefore considers them as independent researchers.

Q) The Rules for Participation state that at the submission deadline for the Letter of Intent (LOI), Principal Investigators (PI) of Individual Research Projects and Consortium Coordinators (CC) and Consortium Principal Investigators (cPI) of Collaborative Research Projects must be principal investigator on at least one active, competitive research grant, and that mentored awards and training grants do not qualify. What is meant by "mentored awards and training grants"?

A) Mentored awards and training grants refer to grants with the inclusion of a mentor or supervisor. The researcher may be named as the Principal Investigator but the award of the grant was also dependent on the inclusion of a mentor or supervisor role.

Examples of mentoring and training grants: Juan de la Cierva, Sara Borrell, Marie Skłodowska-Curie Fellowship.

Please note that this does not mean that researchers holding these awards are not eligible to apply to the PMRP. Applicants may be beneficiaries of mentored awards and training grants, providing they meet all of the eligibility criteria, including the need to be the Principal Investigator on at least one active, competitive research grant at the submission deadline.

Q) Does a Ramon y Cajal count as an active, competitive research grant?

A) Yes, it does. As the Ramon y Cajal grant is awarded to an individual researcher and does not require the inclusion of a mentor figure, it is considered as a competitive research grant in the PMRP 2025 Call.

Q) I have recently been awarded a grant (before the summer) but the project has not started yet. Can I still apply to the PMRP?

A) At the submission deadline for the LOI, all applicants must be Principal Investigator on at least one active, competitive research grant. Unfortunately, if the newly awarded grant is not active before the LOI submission deadline, you would be ineligible to apply to the PMRP 2025 Call unless you are currently the PI on another active, competitive research grant.

Q) Is it possible to "share" the role of Principal Investigator or Consortium Coordinator?

A) No. Only one researcher can be named as Principal Investigator or Consortium Coordinator. The role of co-PI or co-CC does not exist in this call.

Q) Is it possible to "share" the role of Consortium Principal Investigator?

A) No. Only one researcher at each partner institution can be named as Consortium Principal Investigator. The role of co-cPI does not exist in this call.

Q) What is considered to be a proven track record?

A) A proven track record will include demonstrable achievements in terms of scientific publications as main author, grants awarded as principal investigator, presentations at prestigious national and international conferences, awarded prizes, granted patents. Achievements may vary according to a researcher's area of research and career stage.

Q) Can an individual participate in multiple projects in the PMRP 2025 Call?

A) No. An individual can only participate in one project in the PMRP 2025 Call, regardless of their role (Principal Investigator, Consortium Coordinator or Consortium Principal Investigator).

Q) Can an individual participate in a project being submitted to the PMRP 2025 Call and a project being submitted to the Carles Colomer Prize for Multiple System Atrophy Research 2025 Call?

A) No. An individual can only participate in one PMRP application in 2025 regardless of their role (*i.e.* PI, CC or cPI), or the specific call (namely PMRP 2025 Call or Carles Colomer Prize for Multiple System Atrophy Research 2025 Call).

Q) Can an individual participate in a PMRP 2025 Call project if they are the Principal Investigator (PI) or Consortium Coordinator (CC) of a project funded in a previous PMRP Call?

A) A PI/CC of an active PMRP-funded project may participate in the PMRP 2025 Call as a Consortium Principal Investigator (cPI) but may only submit an application as PI/CC if the expected start date of the new project would be after the end date of their ongoing awarded project. The Selection Board is asked to take into account each project's suitability for inclusion in the Foundation's portfolio of <u>intramural</u> and <u>extramural</u> projects.



Q) Can an individual participate in a PMRP 2025 Call project if they are a Consortium Principal Investigator of a project funded in a previous PMRP Call?

A) A Consortium Principal Investigator in a project funded in a previous PMRP Call can participate in the PMRP 2025 Call as a Principal Investigator/Consortium Coordinator or Consortium Principal Investigator.

The Selection Board is asked to take into account each project's suitability for inclusion in the Foundation's portfolio of <u>intramural</u> and <u>extramural</u> projects.

Q) Can an organisation participate in multiple projects in the PMRP 2025 Call?

A) Yes. There is no limit to the number of projects in which an organisation may participate.

Funding Principles

- Q) Does the €800,000 include the contribution to indirect costs?
- A) Yes. The maximum grant award is €800,000 and this must cover direct and indirect costs.
- Q) If the duration of a research project is less than 5 years, can the maximum budget of €800,000 still be requested?
- A) Yes, the maximum funding is €800,000 regardless of the duration of the project. Every research project is different. Please determine the project duration based on the length of time required to carry out the proposed research project. Similarly, please calculate the project budget based on the funds required to undertake the research project. At Full Proposal stage, the justification of the budget requested to undertake the research project is subject to evaluation.
- Q) Is the maximum budget allocation higher for Collaborative Research Projects than for Individual Research Projects?
- A) No, the maximum grant award is €800,000 for both types of projects.
- Q) Do indirect costs (overheads) need to be 21% of total eligible direct costs?
- A) No. The maximum contribution to indirect costs (overheads) is 21% of the total eligible direct costs. It is not necessary for applicants to request the maximum contribution.
- Q) Can subcontracting costs be included in the indirect costs calculation?
- A) Yes, indirect costs may be a maximum of 21% of total eligible direct costs (personnel, travel, equipment, consumables, other direct costs <u>and subcontracting</u>).
- Q) If one institution in a Collaborative Research Project requests overheads of less than 21% of their total eligible direct costs, can another institution request more than 21%?
- A) No. Institutions from a Collaborative Research Project may request a different contribution to indirect costs. However, the maximum indirect costs contribution that can be requested by each institution is 21% of its total direct costs.
- Q) What does it mean that the "budget must be reasonable, clearly justified, and distributed according to the expected timeline of the research activities"?
- A) Reasonable: the budget requested should reflect the expected cost of executing the proposed research project taking into account the actual personnel, goods and services required. The



organisation's usual practices must be followed and under no circumstances should the costs be excessive.

<u>Clearly justified</u>: all direct costs included in the budget must be strictly necessary to carry out the research project and their direct relation to the project must be well explained.

<u>Distributed according to the expected timeline of research activities</u>: the budget distribution should be in line with the timeline of the proposed research activities rather than simply averaged over the duration of the project.

Q) Will the grant amounts awarded be the same as the grant amounts requested?

A) Yes, normally the grant award will match the budget requested. However, if deemed appropriate by the Evaluation Committee or Selection Board, the Foundation reserves the right to offer a grant for only part of the requested budget. This may happen if, for example, specific budget items seem excessive or unnecessary to execute the project. One of the questions that the evaluator is asked is if there is a clear justification of the funding requested to execute the proposed research project, taking into account resources already available.

Q) In the case of Collaborative Research Projects, if there are two Partner Institutions outside Spain is the 30% budget limit applied to each institution?

A) No. A maximum of 30% of the budget can be assigned to institutions outside Spain. If there are two Partner Institutions located outside Spain, their <u>combined budget</u> must be a maximum of 30% of the total budget requested for the project.

Q) In the case of Collaborative Research Projects, is there a maximum or minimum budget that can be assigned to the Host Institution or any given Partner Institution?

A) No. The only limit in terms of the budget distribution between the Host and Partner Institutions relates to the maximum of 30% that can be assigned to institutions outside Spain.

Q) Is an external audit report required regardless of the budget requested?

A) Yes, all expenditure must be audited. An audit report must be submitted with each financial report. In the case of Collaborative Research Projects, the expenditure of the Host Institution and each Partner Institution (regardless of the budget assigned to them) must be audited. Whenever possible, the Host Institution should coordinate the audit on behalf of the Consortium.

Q) Why should the Host Institution coordinate the audits of the financial reports whenever possible?

A) This option tends to be less expensive than the alternative of each partner paying for their own audits and as a result there are more funds available for the research project. If it is not

possible for the Host Institution to coordinate the audits to accompany the financial reports, please contact the PMRP Team (researchgrants@fpmaragall.org) at Full Proposal stage.

Q) Does the external audit need to be carried out by the same company that audits the institution's annual accounts?

A) No. The external audit company should be appointed according to the institution's usual practices.

Q) Is there a limit to the amount that can be spent on the audit of the project?

No. As projects may vary in duration and budget, there is no limit. Please estimate the cost of the audit based on your organisation's experience.

Q) Is it possible to include part of the Principal Investigator's / Consortium Coordinator's / Consortium Principal Investigator's salary in the budget?

A) Yes. A maximum of 20% of the total <u>direct</u> costs of the budget can be allocated to this type of salary costs.

Example: if an Individual Research Project requests the maximum funding of €800,000 (including overheads at 21% of direct costs), a maximum of €132,231.41 can be assigned to the Principal Investigator's salary costs.

In the case of Collaborative Research Projects, the 20% limit applies to each institution's total direct costs and not the total direct costs of the project.

It is possible to include a contribution to the salary of the PI/CC/cPI, providing that they are hired by the host/partner institution, there is no incompatibility with the original source of salary funds, the time budgeted is in line with the time dedicated to the project, there is no double funding (their salary is not already fully recovered by other grants), and the expenditure is incurred in line with the host/partner institution's usual practices.

Q) Is it possible to include part of the salary of members of the Research Team, including those with permanent contracts?

A) Yes, providing they are employed by the Host/Partner institution, there is no incompatibility with the original source of salary funds, there is no double funding (their salary is not already fully recovered by other grants) and the expenditure is incurred in line with the host/partner institution's usual practices. The amount requested should be proportional to the percentage of time that the team members dedicate to the research project. A detailed explanation for this type of cost is required at Full Proposal stage.



Q) Are salary costs during short periods of absence eligible?

Yes. Salary costs during short periods of absence (less than or equal to 90 days) can be covered by the grant.

Q) Is there a limit to the amount of the budget that can be allocated to subcontracting?

A) No. However, subcontracting costs in excess of 30% of the total eligible direct costs will be reviewed carefully and will need to be particularly well-justified.

In the case of Collaborative Research Projects, the 30% applies to each institution's total direct costs and not the total direct costs of the project.

Application

- Q) Is it compulsory to use the online grants system?
- A) Yes, all applications must be submitted via the online grants system.
- Q) Can an application be submitted in Spanish?
- A) No, all applications must be submitted in English.
- Q) Can supplementary documentation be submitted to support the application?
- A) No, only the requested documentation can be submitted. Additional documentation such as letters of support, letters of recommendation etc. cannot be submitted.
- Q) Does a Letter of Intent (LOI) need to be submitted before a Full Proposal?
- A) Yes, the PMRP 2025 Call is a two-stage application process. All applicants must submit a LOI and those whose LOIs are evaluated most favourably will be invited to submit a Full Proposal.
- Q) I have completed the eligibility quiz on the online grants system, answered "yes" to all of the questions and I see a message stating that I may not be eligible to apply. I am not sure what the problem is.
- A) The "correct" (eligible) answer to all of the questions is not yes. Please review the wording of the questions and your answers. Answering yes to the final question "Are the results of the project subject to any type of rights held by for-profit institutions at the time of submission?" would generate the message stating that you may not be eligible to submit a proposal.
- Q) Is it possible to change the application type (individual/collaborative) after starting my application?
- A) Yes, please contact the PMRP Team (<u>researchgrants@fpmaragall.org</u>) and they will make the change on the online grants system for you.
- Q) How do I update the read-only information in the application form?
- A) There are various fields in the application information and track record tabs that are completed automatically with information from the user profiles. After updating the profile, the information in the application form will be updated automatically.



Q) Why is it not possible to submit my application?

A) Please click on the Validate button to identify any potential missing/incomplete information or attachments.

Q) At what stage is Ethics Approval required?

A) Approval from the appropriate ethics committee(s) is required before the relevant project activities are carried out. A copy of the approval does not need to be submitted at any stage of the application process. However, a copy of the approval will be requested by the Pasqual Maragall Foundation before the start of any relevant project activities.

Q) Is it possible to make changes to the consortium at Full Proposal stage?

A) No. The evaluation of the track record of the Consortium Coordinator and the Consortium Principal Investigator(s) is weighted heavily in the evaluation of the LOI therefore it would be unfair to other applicants to allow any changes to be made to the consortium.

Q) Is it possible to make changes to the research project at Full Proposal stage?

A) No, no significant changes can be made to the research project. As a general rule, the publishable lay summary and scientific abstract provided in the Letter of Intent cannot be edited in the Full Proposal.

Q) How do proposals aiming to analyse data from the BBRC's ALFA Study indicate this in the Letter of Intent (LOI) form?

A) In the Project Overview section of the LOI, applicants must specify whether their project includes the use of the ALFA study. If the answer is yes, they must provide a detailed explanation of the data to be analysed in the "Brief project description, including methodology" section of the online form. They will also be asked to complete an additional form (ALFA Data and Samples Request Form available on the online grants system) to indicate the data/data and samples they would like to access.

Q) Where can I find more information about the BBRC's ALFA Study?

A) More information about the ALFA Study can be found here.

Q) Is it possible to request the prospective collection of samples from ALFA Study participants?

A) Yes. Applicants wishing to request data or samples that are not currently collected as part of the ALFA Study should clearly state this in the additional tab of the ALFA Data and Samples Request Form (template available on the online grants system). The sample size, timeline, and data required must all be specified.



Q) Is it possible to add procedures to the ALFA Study?

A) Yes. There is an additional tab in the ALFA Data and Samples Request Form (template available on the online grants system) for applicants to indicate any procedures they would like to add to the ALFA Study. Please provide as much detail as possible and include the sample size, timeline and data required.



Evaluation

Q) Are Collaborative Research Projects viewed more favourably than Individual Projects?

A) No. All projects are evaluated based on their excellence. Projects should only be submitted as Collaborative if deemed necessary to carry out the proposed research project.

Q) Are Consortiums including Consortium Principal Investigators from international institutions viewed more favourably?

A) No. Consortium Principal Investigators should be selected taking into account the requirements of the proposed research project and not their geographical location.

Q) Are Projects including the BBRC's ALFA study viewed more or less favourably than others?

No. All projects are evaluated based on their excellence.

Q) Will each grant be awarded to a project focusing on a different call topic?

Not necessarily. All projects are evaluated based on their excellence therefore more than one grant could be allocated to the same topic.

Q) Will it be evaluated positively to have young independent PIs as part of a consortium or do you prefer to have only well-established PIs?

A) The PMRP 2025 Call welcomes applications from all independent researchers, regardless of their career stage. No preference is given to younger researchers nor is it given to more experienced ones. Activity during the track record evaluation period (last five years or extended period if applicable) is what is taken into account.

Q) Why might an application be rejected before it is evaluated by the external experts?

A) All applications must fulfil the eligibility criteria for the call (please see section four of the Rules for Participation). The eligibility of all applications is verified by the PMRP Team and ineligible proposals will not be evaluated.

Incomplete applications will also be considered ineligible therefore it is important to ensure that all sections of the online form are fully completed.

Applications may also be rejected for failure to respect the application instructions, for example established character/page limitations, to ensure a fair competition for grant funding.

Q) Is feedback provided to all applicants?

A) All applicants are informed of the outcome of their LOI but detailed feedback is only provided to applicants invited to submit a Full Proposal.

At Full Proposal stage, all applicants are provided with a detailed evaluation report.

Q) Where can I find the Pasqual Maragall Foundation's strategic plan?

A) The strategic plan is published on the Foundation's website here.

Q) Where can I find details about the projects selected for funding in previous PMRP calls?

A) Details of the projects selected for funding in previous PMRP calls can be found on the Foundation's website here.

Grant Management

- Q) Are there any additional requirements for the Host Institution prior to signature of the Grant Agreement?
- A) Yes. The Host Institution will be required to provide additional documentation e.g. to demonstrate that it is up to date with its tax and social security obligations.
- Q) Will it be possible to make changes to the budget during the life of the project?
- A) Yes, but prior approval by the Pasqual Maragall Foundation will be required.
- Q) Will unspent budget be automatically carried forward to the following year?
- A) Yes, but all budget variances must be explained in the annual financial reports.
